Rep. Brent's Future Legislation

Aisha's Law

Joint Sponsor: Rep. Sara Carruthers

- Require officers who handle domestic violence complaints to be trained in Intervention techniques
- Expands "aggravated murder" to also prohibit purposely causing the death of a family or household member
- Creates "emergency protection order" on behalf of a victim of domestic violence, if the court is not available for regular business.

Pet Tax Credit

Joint Sponsor: Rep. Sharon Ray

- Provides a Tax credit for landlords that allow companion animal
- The tax commissioner will compile and publish (tax department's web site) a list of landlords who claim the credit
- The Tax credit is not allowed unless the claimant provides the address of each unit that are permitted pets, and a copy of the landlord's policies.

The 2024-2025 State Budget totals \$190.7 Billion.

Education

- Governor is given authority of schools over State School boards
- Grades 6 -12 students access free feminine hygiene products
- Universal School Voucher
- Increases minimum teacher salary to \$35,000

Taxes

- Sales Tax Exemption for Baby Products
- Income Tax Exemption for Minors
- Indexes Homestead Exemption to inflation
- Increases sports gaming tax rate from 10% to 20%.

Health / Senior Citizens

- Increased Medicaid reimbursement for Dental, Vision, and Ambulance
- \$2.5M Healthy Beginnings at Home (stable housing for pregnant mothers)
- Extends Medicaid coverage to workers with disabilities aged 65 and older
- Continuous Medicaid for children 0 – 3

Money Rep. Brent Secured in the State Budget
