Working For You: Spring 2022 at the Ohio Statehouse

Dear Neighbor,

April was a busy month, and May is shaping up to be even busier. On April 20th, I formally introduced the initiated statute sponsored by the Coalition to Regulate Marijuana Like Alcohol, which seeks to legalize recreational adult-use cannabis in Ohio.

The Coalition submitted petition language and 207,000 signatures to the legislature on January 28, 2022. The General Assembly has until May 28 to act on this legislation, otherwise the Coalition has the option to collect additional signatures to submit the proposal directly to the voters in November, where I believe it will pass.

In April, I also had the pleasure of holding two Hudson town halls to discuss current legislation and where we stand on redistricting. Stay tuned for details on our

town hall coming to Cuyahoga Falls this summer.

And finally, with the leaked Supreme Court Opinion that was released last week, I want to reiterate my commitment to defending women's fundamental rights to healthcare and to control over their own bodies.

We have also introduced several other bills to better support our students and educators, including

- HB 333—To create a specialized school counselor job descrip-
- HB 353—The Testing Your Faith Act, to guarantee students of higher education have absences for religious obligations
- <u>HB 619</u>—To allow school districts to permit student mental health days.

Supporting our teachers also means fighting hard against bill like HB 327 and HB 616, which seek to censor educators in the classroom by banning so-called "divisive concepts." We cannot hide from history, and these bills will only make educators' jobs harder.
