Spotlight: Ohio Ballot Board Changes Amendment Language

The Ohio Ballot Board met last month to approve ballot initiative language for issues in the upcoming November election. While the language for the marijuana legalization amendment was approved with no changes, the Republican-controlled board rejected using the <u>full text of the proposed reproductive freedom amendment</u>.

The changed language—passed by a 5-2 vote—is deceptive and does not reflect the actual language of the amendment. The approved language ignores official medical terminology and uses the phrase "unborn child" rather than

"fetus." The language also misleadingly refers to abortions as "decisions" rather than "medical treatment."

The deceitful ballot language even goes as far as to not include the fact that the amendment protects all reproductive rights including contraception, abortion, and infertility.

The truth is, a constitutional amendment would guarantee the right to make and carry out one's own reproductive healthcare decisions, which include all options and is something a majority of Ohioans support. Where the original language discusses viability. this new ballot language discusses abortions at term, which is not medically possible and is just called delivery.

Reproductive rights groups who helped create the original ballot language have sued the Ohio Ballot Board for their "deceptive summary," asking the Ohio Supreme Court either to use the full amendment's language or to require the Ballot Board to correct the inaccuracies.

Legislative Update

HB 197: Community Solar Bill / This week we will be hearing proponent testimony on House Bill 197 in the House Public Utilities Committee, which if passed would establish a community solar pilot program in Ohio. Unlike personal rooftop solar, community solar allows multiple customers—businesses, neighbors, etc.—to subscribe to energy generated by a nearby, off-site solar array.

This is the second General Assembly that a community solar bill has been introduced in the Ohio House. Last GA, HB 450 had six committee hearings before

ultimately stalling out. Testimony was overwhelmingly positive, with AEP Ohio as the only listed opponent.

Community solar is an issue with growing bi-partisan support. Both leading
