House Republicans have followed the trend of states such as Texas, Arizona, and Georgia by introducing House Bill 294, a bill that is anti-voter. The bill’s intention is misleading and harmful. Instead of ensuring every Ohioan has the freedom to vote and cast their ballot, House Bill 294 limits ways to cast ballots and attacks voters, especially elderly and poor Ohioans.

We all want safe and accessible elections, but Ohio Republicans are pushing the anti-voter legislation that will takes us in the wrong direction. House Bill 294 is a divisive and dangerous anti-voter bill that contains many attacks on our freedom to vote. Any bill that rolls back our right to vote is a non-starter. Period. Ohio already has enough anti-voter laws. We don’t need anymore. We don’t need House Bill 294. Instead we should pass legislation that expands the right to vote and lifts burdens like expanding drop boxes. My House Democratic colleagues and I have been hearing directly from Ohioans about protecting their freedom to vote. Join me this Monday, June 7th in Toledo.

In May, the first ever Virtual Women's Lobby Day hosted by the Ohio Democratic Women's Legislative Caucus was a success. This LGBTQ+ Pride Month, I join my House Democratic colleagues calling for action on the Ohio Fairness Act, bipartisan legislation that would protect LGBTQ+ Ohioans from discrimination in employment, housing and accommodations. The legislation was introduced yet again as House Bill 208 by Democrats in March 2021 and was referred to the House Commerce and Labor Committee, but has yet to receive a committee hearing.

Currently, qualified and competent employees can lose their jobs because of who they are or whom they love. Ohio should be a welcoming place to attract and retain the most talented workers. Passage of the Ohio Fairness Act fulfills the Ohio Promise as it will make Ohio a welcoming place to live, raise a family, work and retire. In June 2020, the [U.S. Supreme Court ruled](#) that LGBTQ+ workers are protected from workplace discrimination under federal

law. The Ohio Fairness Act goes further by expanding LGBTQ+ protections to include not just employment, but also housing and services in Ohio.

Democrats have also previously introduced legislation which would protect minors by prohibiting certain licensed health care professionals from engaging in conversion therapy when treating minor patients.

Additionally, Democrats strongly oppose anti-transgender bills like HB 61, Republican legislation which would further stigmatize and discriminate against already marginalized trans-youth.

During Pride Month and beyond, I am committed to making Ohio an inclusive and welcoming place for all people.
