#### Skylift Inc. Tour and New Product Line

On Thursday, August 15th, I got the chance to tour the Skylift Facility in Lorain. Skylift makes equipment for utility pole and transformer installations, tree trimming, and other applications. One of my former students, DJ Simonovich, is

now an engineer for Skylift and designed Skylift's new articulating telescopic boom product line.

- The first two models created are the Skylift SBA-55i and Skylift SBA-47i.
- The photo to the left shows the first SBA-47i mounted on a Ford F550 chassis, which are produced right in the district in Avon Lake.



## Ohio Tax Credit Authority approves Tax Credit for Camaco Lorain Manufacturing

This August, the Ohio Tax Credit Authority approved a 1.325%, eight-year Job Creation Tax Credit for the Camaco Manufacturing Facility in the City of Lo-



rain. This is as a result of an expansion project in Lorain, which expects to create 104 full-time equivalent positions generating more that \$5.2 million in new annual payroll. The proposed projects involves acquiring a new facility that will allow for increase production capacity made possible by new contract. I am excited for this new economic growth in the district.

#### State Board of Education Controlling Board Funding

During the 8/19 Controlling Board Meeting, the members approved a on-time allocation in the amount of \$4.66 million to the SBOE's Teacher Certification and Licensure Fund. This allocation was made following a deficit with the SBOE's Licensure Fund that would have dramatically increase the amount that educators are spending out of pocket each year and could contribute to deterring new educators from joining the workforce and potentially push current one's out due to the cost.



While this funding is a step in the right direction, my **HB 516** would provide a yearly allocation to the SBOE's Licensure Fund, providing a more permanent solution to the deficit. The bill had its first hearing in the House Finance Committee on 6/12/2024, I am looking forward to future hearings. #### **Beginning Farmer Tax Credit**

This tax credit was created by House Bill 95 in the 134th General Assembly. A beginning farmer is an Ohio resident who is looking to enter the farming industry or has less than 10 years of experience as a farm owner or operator. This program offers income tax credit opportunities in two categories:

- Beginning farmers who attend a financial management program.
- Individuals/businesses that sell or rent farmland, livestock, buildings, or equipment to beginning farmers.



#### Ohio Residential Broadband Expansion Program

The Ohio Department Of Development recently announced a state investment of \$94.5 million that will provide affordable, high-speed internet access to more than 35,000 households across the state.



- ORBEG is a competitive grant program designed to fund last-mile broadband infrastructure projects in rural areas currently lacking access to reliable, high-speed internet.
- \$15,287,761 to provide access to 5,289 households in Ashland, Erie, Geauga, Lorain, Lucas, and Wood counties
