Their efforts were crucial during WW2, and they helped pave the way for many black pilots and members of our armed forces.

Also sometime in the coming months the Paul Laurence Dunbar License plate will become available at the BMV! Proceeds for this license plate will benefit the Paul Laurence Dunbar House, with more details coming shortly as to what the license plate will look like and the date in which it will be available.

## State Budgeting Season

Budgeting season is officially in full swing! This is an incredibly important period of time in which legislators work to craft a bill that allocates funding to state agencies to support programs and key functions. By the end of June Governor DeWine will sign into law the operating budget for the next 2 years.



### Budgeting Basics: Must Know Facts

- The State Budget is passed once every 2 years
- Budgets operate on fiscal years– for Ohio the Fiscal Years begin on July 1st of each year and end on June 30th
- Funds are allocated through “line items” to different state agencies. Visit [www.ohio.gov](http://www.ohio.gov) to view a complete list of state agencies and learn more about their operations
- The State runs a balanced budget with revenues just exceeding expenditures
- Ohio’s largest revenue categories are sales tax and income tax
- Ohio’s largest expense categories are Medicaid and Primary & Secondary Education



## HB 38: The Student Mental Health Act

**STUDENT MENTAL HEALTH ACT**

Allows up to three mental health days as excused absences from school

Rep. Blackshear recently introduced HB 38: “The Student Mental Health Act” alongside Rep. Miranda. This important piece of legislation would allow school districts to give students up to 3 days of excused absences from school to address their mental health.

Additionally it allows school districts to provide resources to students experiencing mental health concerns. HB 38 was referred to the House Primary & Secondary Education committee where it awaits a first hearing.
