Happy August! As many of you know, Ohio is holding a special election on August 8th. Early voting started in July and will continue until August 6th at 5 pm. As Election Day approaches, make a plan to vote "NO" on Issue 1:

- **July 11:** Early Voting began
- **August 1:** Absentee ballot applications must be received by your board of election by 8:30 pm.
- **August 7:** Mailed absentee ballots must be postmarked by this date
- August 8: Election day (Polls are open from 6:30 am to 7:30 pm.

Issue 1 is an unpopular, and undemocratic attack on the people and our sacred constitution. It will shred our founding document, it will end majority rule in our state, and it will snuff out the principle of "one person, one vote." We must defeat Issue 1 to protect our freedom to determine our future. Make sure your voice is heard and vote "NO" on Issue 1. #VoteNoInAugust
