State Representative Sean Patrick Brennan Continues to Amplify Your Voice for Lower Utility Prices

Ohio lawmakers scrutinize FirstEnergy's proposed \$190M rate hike

As Ohioans grapple with rising utility costs amid extreme weather, some state lawmakers are expressing concern over a proposed rate hike by FirstEnergy. The company has requested that the Public Utilities Commission of Ohio (PUCO) approve a \$190 million increase, arguing that current base distribution rates are insufficient for reasonable electric distribution compensation.

FirstEnergy's request comes as the PUCO faces scrutiny for its involvement in the House Bill 6 scandal, which implicated former PUCO leader Sam Randazzo and former House Speaker Larry Householder.

State Representative Sean Brennan (Parma) voiced frustration shared by many residents over utility bills.

"The utilities really have an inordinate amount of power, despite the fact that the power should really rest in the hands of the people," said Brennan. He added, "If things were done in a more transparent manner, I think they'd have a lot more credibility."

Both the PUCO and First Energy declined to comment on the House Bill 6 hearings but stated that the rate increase request "aims to recover costs of providing distribution service to customers, including significant service reliability improvements made in recent years."

Earlier this year, <u>AEP Ohio also sought a rate increase from the PUCO</u>, which would raise residential base rates by nearly \$4 per month for those using an average of 1,000 kilowatt-hours per month. AEP noted that resources such as payment arrangements and energy management tools are available to assist customers.

The PUCO's review process for these rate increases is expected to take more than a year.

State Rep. Brennan Passes Bipartisan Reform Bill to Protect Children

I am pleased to share that the Ohio House of Representatives recently passed (97-0) House Bill 168, legislation I sponsored with Rep. Josh Williams (R-Sylvania Twp.) to strengthen Ohio's child enticement statute while ensuring it is both constitutional and enforceable.

This bipartisan bill is an important step forward in keeping children safe while also upholding the constitutional protections all Ohioans deserve.

The need for this legislation stems from a 2014 Ohio Supreme Court ruling (*State v. Romage*) that found the existing statute overly broad and unenforceable. That ruling left law enforcement without a clear tool to prosecute dangerous behavior. HB 168 provides that much-needed clarity

Key provisions of HB 168 include:

- Narrowing the law so that it applies when a child is enticed with sexual motivation or an unlawful purpose.
- Increasing penalties for sexual-motivation cases, elevating them from a first-degree misdemeanor to a fifth-degree felony, with further enhancements for repeat offenders.
- Clarifying what constitutes "unlawful purpose" in non-sexual cases.

Law enforcement leaders have told us they need this fix, and their input helped shape the bill. I also want to recognize former State Rep. Richard Dell'Aquila, who introduced a version of this legislation in the last General Assembly and laid important groundwork for our success.

As I said on the House floor: "We must protect our children from harm—but we also must ensure our laws are constitutional and targeted. House Bill 168 strikes that balance."

The bill now moves to the Ohio Senate for further consideration. I look forward to continuing this bipartisan work to protect Ohio's children.




