As you may know, in 1938, following World War I, Congress created Armistice Day to honor our veterans of the Great War on 11-11, the date in 1918 when the armistice was signed ending the hostilities at 11:00 am. Later, in 1954, following World War II and the Korean War, President Dwight D. Eisenhower signed the law changing the holiday to Veterans Day to honor all of our nation's military veterans.

State Representative Brennan Supports Military Veterans Funding

As a state representative in my first term, I proudly supported the funding items list here which directly benefit Ohio's veterans, all of which passed this past summer.

Representative Sean Patrick Brennan Announces \$4.16 Million Award to Parma Schools

COLUMBUS - State Representative Sean Patrick Brennan (Parma) has announced that the Parma City Schools have been awarded a \$4,116,570 Career Technical Construction Program grant from the state of Ohio. The Ohio schools selected for the grants were awarded nearly \$200 million to help expand career technical educational and training facilities to serve more students.

"One of the gems of the Parma City Schools is their career tech program. Program director Kristen Plageman and her team have put together a top notch program that leads to students leaving high school with the skills necessary to immediately enter the job market. In fact, they have received very high marks in every category of the state report card. These funds will go a long way in making their program even stronger. I could not be prouder!"

59 schools throughout the state applied for funding with 35 being selected in a competitive selection process. The Parma City School District will use the funds to expand their auto collision and carpentry programs. It will provide the students with state-of-the-art facilities in which to learn and hone their skills. The Parma City Schools offer a robust catalog of career technical education choices for students, including culinary arts, cosmetology, medical professions, carpentry, auto collision, business/computer skills, digital media creative arts, biotechnology, networking/advanced computers, dental technologies, medical professions, cooperative marketing management, and engineering.

COLUMBUS – The Ohio House of Representatives recently passed House Bill 187 - the Ohio Homeowners Relief Act. State Representative Sean Patrick Brennan (Parma) was one of three Democrats who supported this legislation which will protect Ohioans by modifying the procedures used to calculate property valuations.

"Property values have gone up dramatically over the past few years. I voted to support HB 187 in committee and on the floor to ease the rising property tax burden facing homeowners, many of whom are on fixed incomes, which is one of my top priorities" State Representative Brennan said.

The bill will require county tax commissioners to work alongside local elected officials to weigh the past three years of a county's property values in order to determine property tax, instead of just one.

In addition to the Ohio Homeowners Relief Act, Rep. Brennan co-sponsored House Bill 33, the Ohio state budget, which included a provision to automatically increase Ohio's Homestead Exemption to combat inflation, providing further property tax relief for elderly Ohioans and disabled veterans.

The Ohio Homeowners Relief Act has been sent to the Ohio Senate for further consideration.



Governor DeWine Orders Flags at Half-Mast in Honor of Congressman Mottl

Back in January, soon after Governor Michael DeWine and I were sworn in, I wrote a note to the Governor expressing what an honor it was to serve with him and how I looked forward to working with him. In return, the Governor sent a note back thanking me and inviting me to call him if I ever needed anything. What an honor it was that he included his personal cell phone number. I have only called that number twice. Once to make him aware that \$200 million in foodbank assistance from the state had not been distributed in a timely manner. Within days, low-and-behold, Lisa Fugitt, Executive Director of the Ohio Foodbanks Association, called me to tell me that the dollars has been dispersed. The next time I called him, I asked if he would consider flying the flags at the Ohio Statehouse at half-mast in honor of Parma's own Congressman Ronald Mottl. I am happy to report that on November 15, he did so. These are good examples to illustrate how working across the aisle does occur and leads to good outcomes when elected officials work together in good faith.
