This October, my office has been busy hosting three townhalls across District 22. The first was a Small Business Town Hall and Resource Fair where attendees had the opportunity to network with each other and connect with state, local, and private small business resources. ## SNAP

As of tomorrow, November 1<sup>st</sup>, SNAP benefits will expire for nearly 1.4 Million Ohioans. The federal shutdown and a failure by the state republican majority to act, will cause the 190,000 Cuyahoga county SNAP beneficiaries to go without food assistance. Ohio's food banks are already strained as it is following the president's "One Big Ugly Bill" that cut SNAP federal spending and Ohio's state budget that provided \$7.5 million less for food banks compared to 2024.

Not only is this a humanitarian crisis, it is an economic one as well. Cuts would negatively impact Ohio's economy as every \$1 in SNAP spending generates \$1.54 in economic activity. That would be a huge blow to grocers, farmers, truckers, and small businesses across the state.

My office alongside the Ohio House Democratic Caucus has urged Governor DeWine and republican state lawmakers to immediately address this issue. While Governor DeWine issued an executive order to provide \$25 Million for food assistance, this is not enough. House Democrats raised the urgent issue of the SNAP funding crisis on the House floor earlier this week via an amendment that would provide full relief for Ohioans under SNAP. House Republicans voted down the proposed amendment, stating that SNAP benefit funding is not an Ohio issue. Overall, the federal shutdown will cost Ohioans a benefit loss of roughly \$200M per month, nearly eight times the amount of funding provided by the Governor's executive order. Ohio has a \$6 Billion rainy day fund that could help fund SNAP benefits and food pantries and keep Ohioans from going hungry. It is raining here in Ohio and the time is now to address this issue.

If you are in need of food assistance call United Way at 211 or the Greater Cleveland Food Bank at 216-738-2067. Current SNAP recipients should keep their paperwork up-to-date, maintain all program requirements, and keep recertifying your benefits as you normally would even if no new benefits are added in November. This is so when the shutdown ends and/or SNAP benefits return, you can continue to receive benefits as normal and potentially be owed back-benefits.

## HB 548 and HR 266

This month, Rep. Brewer introduced two pieces of legislation regarding police violence in Ohio.

**House Bill 548** requires testing for alcohol and drugs after an officers use of force, bringing heightened transparency to incidents of use of force involving a law enforcement officer. This bill aims to provide protections for officer's who are policing the right way, while guaranteeing accountability for those who are not. This bill is not about punishment. It is about transparency, accountability, and restoring public trust in our justice system.

**House Resolution 266** recognizes October 22 as the National Day Against Police Brutality in Ohio. . Since the mid-1990s, individuals and movements across the nation have held October 22<sup>nd</sup> as a day of protest and reflection on the impact of police brutality. Each year, the National Day Against Police Brutality is observed by advocates, faith leaders, and families who seek not division, but reform and healing. By recognizing this day in Ohio, we elevate our state's voice in that national movement, standing for justice, compassion, and systemic improvement. This legislation not only highlights this day of protest but remembers the more than 1,200 Ohioans who have tragically lost their lives to incidents of police brutality since the year 2000.

Rep. Brewer introduced this legislation on October 22<sup>nd</sup>, alongside advocates and families who have been impacted by police violence.
