NURSING MOTHERS AND JURY DUTY

I have introduced legislation that will provide more critical time for mothers to bond with their newborn babies by excusing <u>nursing moms</u> from jury duty.

Currently this is not an excusable exemption from serving on a jury and puts a strain on mother's that need to nurse their children.

My legislation would allow for nursing mother's with children one-year-old and younger to be released from serving on a jury if they choose.

Woke Finance is hurting ohioans

Currently there is social-political movement in our state and country called environmental, social, governance (ESG) investing.

ESG is not in the best interest of Ohioans. When ESG policy decisions are utilized instead of traditional fiduciary responsibilities, Ohioans are the ones who loose. ESG policies threaten Ohio retirees and put energy, manufacturing, and agriculture industries at risk.

ESG's stated purpose is to promote and influence environmental, social justice, and governance standards. One of the primary ways in which financial institutions force ESG upon society is through refusing to service certain businesses and individuals based upon their lack of devotion to ESG mandates.

This practice of economic boycotting is discriminate and potentially crippling to the business community, the backbone of a capitalist society.

To combat this, I will be introducing legislation to put a stop to the practice here in Ohio. This legislation will focus on state contracts between governmental entities and financial institutions and private companies.

This legislation is a priority for the House Republican Majority this General Assembly and has their full support.





INSIDE THE HOUSE OF REPRESENTATIVES

SAFE ACT RETURNS FOR THE 135 THE GENERAL ASSEMBLY

The <u>Save Adolescents from Experimentation</u> <u>Act</u> has been reintroduced from the previous General Assembly.

This critical legislation will protect children experiencing gender identity disorder from premature medicalization by preventing harmful surgeries and prescriptions of puberty blocking drugs and cross-sex hormones to patients under the age of 18.

This will also affirm the rights of parents by requiring a patient under the age of 18 with a gender-related condition, to obtain parental consent. A physician must also obtain parental consent and screen the patient for abuse and other trauma.

This is important legislation to protect our state's youth from making a life-altering decision that is irreversible before a child can fully understand the impact of their decision.

IN THE DISTRICT

I have had the recent honor to meet with a large cross section of the people of this district from students and professors from the University of Northwestern Ohio, our 4-H advisors and members, and many members of local government that make the 84th District a special place.

These first few months of being the new representative of the district I have visited with many constituents in effort to learn more about the issues we are all facing. With the two-year budget now in the process of being prepared I have also spoken with many local organizations and government leaders to see how I can help.
