LEGISLATIVE UPDATE: SNAP

Dear Neighbor,

I am reaching out today with urgent information regarding an update to the Supplemental Nutrition Assistance Program (SNAP). Starting tomorrow, November 1, individuals who qualify SNAP will not receive their regular November benefits due federal to the government shutdown.

There are 1.4 million Ohioans, including nearly 600,000 children, who will be affected by the interruption of SNAP benefits in November. Here at home in Cuyahoga County, we have the largest number of SNAP recipients in the state. More than 190,000 residents—54% of whom are seniors and children—rely on SNAP in the county, and 19,633 residents in District 21 will shoulder the burden of this crisis.

This situation is continuing to evolve, and our office will work to keep you as informed as possible. For now, please see below for steps you can take, available resources, and what actions the state government is pursuing.

WHAT SHOULD SNAP RECIPIENTS BE DOING?

1.Current SNAP recipients should keep their paperwork up-to-date, maintain all program requirements, and keep recertifying your benefits as you normally would even if no new benefits are added in November. This is so when the shutdown ends and/or SNAP benefits return, you can continue to receive benefits as normal and potentially be owed back-benefits.

- 2. If you are in the middle of applying for SNAP benefits, continue to do so. County JFS offices will continue the process applications for when benefits return.
- 3. If you have any leftover <u>October SNAP</u> benefits still on your card, you can still access and use those benefits.
- 4. If you were only <u>recently approved for October</u> SNAP benefits and are still owed those benefits, <u>you will still be able to access them even in November</u>.

WHAT IS THE STATE OF OHIO DOING?

Democrats Urgent Call to Action

Earlier this week, our Democratic Caucus sent a letter to Governor DeWine urging immediate action by declaring a state of emergency and working with the legislature to unlock up to \$100 million in funding to ensure food banks can feed those in need.

Our colleague, Rep. Latyna Humphrey, has **introduced HB 502**, **which would have continued to fund SNAP and other programs in the event of a lapse in federal funding.** The majority has yet to refer the bill to a committee, give it a public hearing, or consider it for a full vote in the House of Representatives.

Additionally, we offered an amendment on the House floor that was not taken up, which would:

- 1. Provide emergency funds to Ohio food banks until the government shutdown ends or SNAP recipients begin receiving their benefits;
- 2. Appropriate \$100 million as needed by food banks to meet increased demand during the shutdown;
- 3. Require the Department of Job and Family Services to work with the Ohio Association of Foodbanks (OAFB) to determine the timeline for distributing funds; and
- 4. Require OAFB to coordinate with Meals on Wheels and similar nonprofit food-delivery organizations to serve disabled individuals, seniors, and others who lack transportation.

Last Minute Decisions

It was only yesterday, that Governor DeWine signed an executive order directing the Ohio Department of Job and Family Services (ODJFS) to give \$7 million though the Temporary Assistance for Needy Families (TANF) funds to various Ohio food banks and up to \$18 million in funds to Ohioans who are at or below 50% of the federal poverty level who already qualify for Ohio Works First (OWF) cash assistance. The Governor's executive order is a necessary start, but without additional funding, Ohio can't cover the gaps in vital food assistance.
