A Legislative Update from the Office of State Rep. Erika White



Friends and Neighbors,

Our votes are our voice and our power. Elections decide the funding for our schools and our libraries to the price of food to the care seniors and kids receive. The choices we make this November will affect every household in our *commUNITY*. Let's make a plan so nothing get in the way of your ballot this November. Pick your method:

Early In-Person Voting:

Early in person voting is 8:00a – 5:00p Monday-Friday and the Saturday and Sunday before election day.

Vote by Mail:

If you applied to vote absentee before the Oct. 28th deadline, your absentee ballot must be postmarked by November 3rd.

Election Day:

Polls are open from 6:30a – 7:30p.

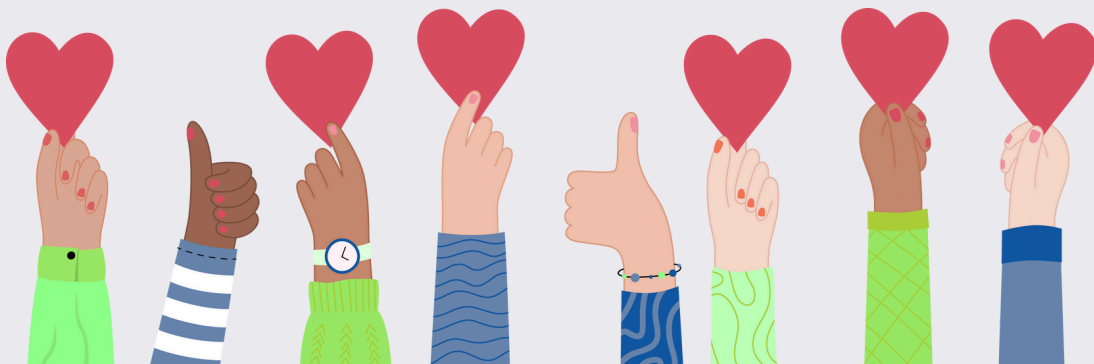

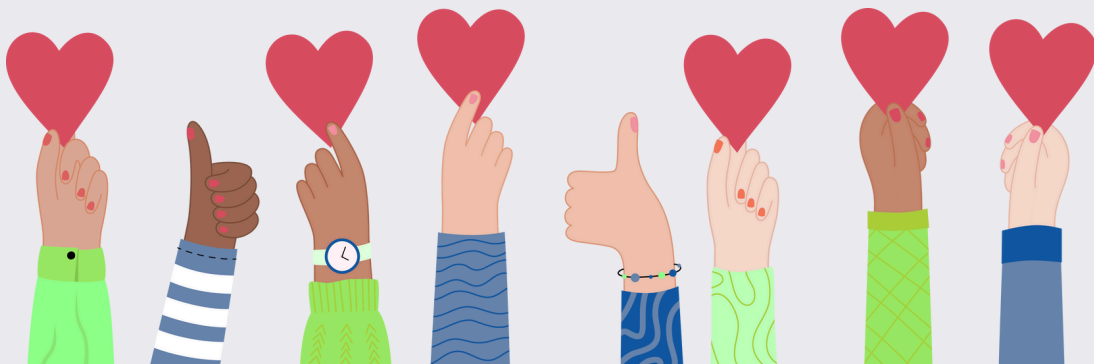

Sponsor Testimony on House Bill 311

Rep. White Signs Letter Urging Governor DeWine to Take Action as the Federal Shutdown Threatens SNAP benefits

The Ohio House Democratic Caucus sent a letter to Governor DeWine urging him to take action to preserve SNAP benefits for 1.4M Ohioans at risk of going hungry beginning November first.

“Governor, we are asking that - by Wednesday- you declare a state of emergency, provide state funds to foodbanks to meet the needs of hungry Ohioans, and mobilize the national guard to distribute food on an as needed basis in coordination with the foodbanks. Ohio families will go hungry without SNAP benefits, including over a half million children, over 250,000 seniors, and an estimated 45,000 veterans. Time is of the essence, and we need to act before Saturday’s deadline,” said House Democrats in their letter to the governor. “It does not matter where we stand on the respective sides of the battle over healthcare premiums in D.C., the reality is that the most vulnerable people across our state are going to go hungry if we do not act. We are urging leadership in the face of this crisis.”

Specifically, House Democrats requested the governor:

- Use his executive authority to immediately declare a state of emergency; and
- Work with the legislature to unlock up to \$100M to ensure that foodbanks can feed those in need citing various funding sources that could be made available and noting Controlling Board’s emergency fund as the most immediate option.

Ohio families should not have to choose between buying food or medicine or keeping the heat on because of the state’s failure to respond to this urgent crisis. You can find the full press release and attached letter by scanning the QR code.



THE WORKLINE

Connecting Bills at Work inside the Statehouse to Your House

H.B. 502

Introduced by Rep. Latyna Humphrey

Makes an appropriation for the use of the State's Rainy Day Fund to continue funding for SNAP, TANF, WIC and other social assistance programs. This legislation is incredibly necessary as SNAP benefits are not being released due to the Government Shutdown. The bill currently sits in the House Agriculture Committee. H.B. 473

Introduced by Rep. Dave Thomas

This bill prohibits a public employer from paying employee contribution on an employee's behalf to a state retirement system. Makes the payment of employee contributions by a public employer on an employee's behalf to a state retirement system not an appropriate subject for collective bargaining agreements. As ranking member of Public Insurance and Pensions, I have expressed recruitment and retention concerns over this bill.

H.B. 150

Introduced by Rep. McNally and Myself

This bill is currently sitting in the House Commerce and Labor Committee. The bill was introduced in response to SB 50 and SCR 3 to reduce protections on child labor. HB 150, or the Clock Out Kids Act requires school employees to report child labor law violations, and increases the penalties for certain child labor violations. It also creates the Minor Labor Law Enforcement Fund.
